Christopher Harbourne — Reform UK's Crypto Donor

Who Is He?

Christopher Harbourne is a British **crypto billionaire** and **former commodities/jet fuel trader** based in Dubai, UAE. He is Reform UK's **second largest donor** (after Zia Yusuf), having donated **£1.9 million** to the party and directly to Nigel Farage personally.

He is: **not** the same Christopher Harbourne who was jailed in 2024 for stabbing (that's a younger man, son of a golf tycoon — a different person entirely).

“ **Note:** Previous total of £1.9m only counted Reform+Farage. The Nerve investigation (23 May 2026) reveals Harbourne has poured ~£30m into UK politics overall, including donations to Boris Johnson and broader political spending.

Business Interests

- **Tether / Crypto:** Primary source of his wealth. Described as a "crypto billionaire" and "Tether figure" with deep ties to the stablecoin ecosystem.
- **Jet fuel brokerage:** Former commodities and jet fuel trader before pivoting to crypto. His company Harbourne Associates Ltd operates in commodity trading.
- **Dubai base:** Operates from the UAE with complex corporate structures that make tracing his finances difficult.

Controversies

Russia / Putin Propaganda Links

Multiple investigations have raised concerns about Harbourne's connections:

- **Byline Times** published a detailed investigation into his Tether links and associations with pro-Kremlin networks
- **The Guardian** reported on "serious questions" about the source of his wealth and Russia links

- **RT connection:** His name has been linked to RT (Russia Today), the Kremlin-backed propaganda outlet
- **Electoral interference concerns:** Questions raised about whether any of his funds originated from Russian sources, particularly given the UK election security context

Direct Payments to Farage

The revelation that Harbourne gave **six-figure sums directly to Nigel Farage personally** (not just the party) sparked widespread criticism and calls for investigation by the Electoral Commission.

Opaque Corporate Structure

- **BBC Panorama** noted he "cannot be traced" and operates from Dubai with opaque business structures
- His non-dom status while donating to a party campaigning on "British values" has drawn particular criticism
- Electoral Commission reportedly reviewing some donations for potential regulatory breaches (as of early 2026)

The Nerve Investigation (23 May 2026) — "The Harbourne Receipts"

A major new investigation by **The Nerve** (Charlie Young & Lucia Osborne-Crowley) published 22 May 2026, promoted by Carole Cadwalladr in a viral thread:

Key findings:

- Harbourne has poured **£30m into UK politics in 6 years** — far more than previously reported
- **Pattern of donation-then-policy:** Harbourne's crypto donations consistently preceded pro-crypto announcements from both Johnson and Farage
 - £1m to Johnson → Johnson's pro-crypto policy announcements followed
 - £5m to Farage → Farage's crypto enthusiasm "took off 2 months later"
- His wealth is **primarily from Tether (USDT)**, a stablecoin with opaque backing
- The UK's regulatory status on stablecoins has been a focus of policies championed by both Johnson and Farage
