Background

Maya Forstater is a tax researcher and gender-critical activist. She worked at the Center for Global Development (CGD) until 2019, when her contract was not renewed after colleagues complained about tweets she had posted stating that sex is immutable and that trans women are men. She sued CGD for discrimination, lost the initial tribunal in 2019, then won on appeal in 2021 in a landmark ruling that established gender-critical beliefs as protected under UK equality law.

Timeline

- **2018-2019:** Posted tweets stating that sex is biological and immutable; colleagues complained
- **Mar 2019:** Contract at CGD not renewed
- **Dec 2019:** Lost initial employment tribunal — judge ruled her beliefs were "not worthy of respect in a democratic society"
- **Dec 2019:** JK Rowling tweeted #IStandWithMaya in support
- **Jun 2021:** Won appeal — Employment Appeal Tribunal ruled gender-critical beliefs ARE protected under the Equality Act
- **2022:** Founded **Sex Matters** with other gender-critical activists
- **2023:** Received payout from CGD for discrimination
- **2024-2026:** Sex Matters achieved charitable status; active in legal challenges and policy advocacy

Ideology & Positions

- Core belief: sex is binary, biological, and immutable; gender identity is not a legitimate legal category
- Argues that recognising gender self-identification erodes women's sex-based rights
- Framing: protecting single-sex services, sports, and spaces
- Legal advocacy approach: strategic litigation and policy submissions rather than street-level activism

Funding & Affiliations

- **Sex Matters** — founder and executive director (registered UK charity)
- **JK Rowling** — received public support from Rowling during tribunal case
- **Fair Play For Women** — collaborated on legal strategy and policy work
- Aligned with broader gender-critical network: LGB Alliance, For Women Scotland, Merched Cymru

Controversies & Criticism

- **Protected belief ruling:** Critics argue the Forstater judgment opened the door for workplace discrimination against trans people under the guise of "protected beliefs"
- **Charitable status of Sex Matters:** Contested by critics who argue it functions as an anti-trans lobbying group, not a legitimate charity
- **Policy influence:** Lemkin Institute (Jun 2025) documented how Sex Matters shapes UK government policy through legal interventions
