Key insight: Reform UK is overwhelmingly funded by individuals, not companies. This is unusual for UK political parties and reflects the "mega-donor" model.

 - Is he offshore-linked?
2. **David John Grainger** (£1.36m)
 - Same questions as Delo
 - Companies House search
 - Background and business interests
3. **Nicholas A C Candy** (£990k)
 - Likely Nick Candy, the property billionaire (brother of Christian Candy)
 - CPC Group (property development)
 - Known high-society figure, married to Holly Valance
 - Check Companies House and previous political donations
4. **Leave Means Leave Ltd** (£990k)
 - Company donation — who owns Leave Means Leave?
 - Companies House search
 - Brexit-era campaign group — connection to Leave.EU / Arron Banks?
 - Is this a pass-through for other donors?

Medium Priority — Deeper Analysis

5. **Full offshore list:** Babelfish claims 18 donors linked to offshore. Get the full list.
6. **Donation timeline:** When did each major donor start giving? Clusters around elections?
7. **Donor overlap:** Which of these donors also give to Tories, Heritage Party, UKIP?
8. **Company donations breakdown:** The 12% company donations — which companies, who owns them?
