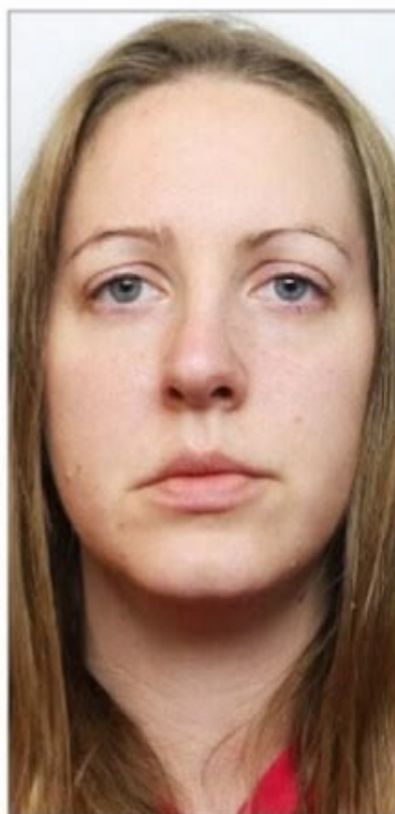

COT cameras will protect babies in neonatal units after an inquiry found three victims of killer nurse Lucy Letby could have been saved.

Lady Justice Thirlwall called for the monitors as her report highlighted a "complete failure" to protect babies in Letby's care at the Countess of Chester hospital.

She said up to three children – two triplet brothers known as Baby O

DAMNING LETBY HOSPITAL REPORT

THEY FAILED AND BABIES DIED

AT least three babies would have been saved if hospital staff had acted sooner to stop killer nurse Lucy Letby.

There was a "complete failure" to protect newborns at the Countess of Chester with parents kept in the dark, an inquiry found.

Health Secretary Yvette Cooper said: "What was happening is reprehensible."

Letby, 36, is serving 15 life terms for the murder of seven babies and attempted murder of seven others in 2015 and 2016.

- **Dan Grennan** — Audience Writer (cover story byline) **Bio:** Dan Grennan is an Audience Writer at the Daily Star, focusing on the Department for Work and Pensions (DWP), benefits and social welfare, plus politics, courts and breaking news. He previously worked for MailOnline, Dublin Live, the Irish Daily Mail, the Irish Mail on Sunday and the Dublin Inquirer, and covered Irish national politics and local government during the Covid-19 pandemic. **Controversies:** None found in public-record searches. IPSO's full-text ruling search for "Dan Grennan" returns no ruling naming him — the four blocks returned (Wallace & Parsons v Manchester Evening News / mirror.co.uk, Dangerfield v Sunday Herald, Taylor v Mail Online) involve unrelated complainants and publications. Notes

- **Byline correction:** the vision read logged the Star's byline as "Dan Greenan"; re-reading the cover image confirms it is printed "**by DAN GRENNAN**", and the linked online story is credited to Dan Grennan (Audience Writer). "Dan Greenan" does not exist on the Star's author directory (that URL 404s).
- All three bylines were re-verified against the cover images and the live article pages before researching (garbled tabloid bylines are common — the Express read on 11 Sep 2026 produced "Manna Geesler" for Hanna Geissler).
- IPSO search caveat: IPSO rulings name publications, not journalists, and its search word-matches, so any hit must be read before it counts as relevant.
